Whereas it is necessary to ensure the smooth flow of traffic and safety of road users on Pusta Road from Kajori Chowk to Shastri Park;


and whereas the problem of congestion/traffic jam on the Pusta Road from Kajori Chowk to Shastri Park due to the movement of Heavy and Light Goods vehicles has assumed serious proportions and is endangering the life of road users;

Now, therefore, I, M.S. Upadhye, Deputy Commissioner of Police, Traffic, Delhi in exercise of powers conferred upon me under Regulation 39 (1) of the Delhi Control of Vehicles and other traffic on Road and streets Regulations, 1960 do hereby prohibit the plying of Heavy Goods Vehicles for 24 hours and plying of Light Goods Vehicles (LGVs) between 8:30 AM to 11:00 AM on Pusta Road from Kajori Chowk to Shastri Park;

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the notice boards of the offices of all Distt. DCOP and all police Stations in Delhi/ New Delhi;

This order shall come into force with immediate effect;
