NOTIFICATION

Whereas it is necessary to ensure smooth flow of traffic and safety of road users and residents of Gali Tel Mill, Ram Nagar, Pahar Ganj Qutab Road, Delhi.

And whereas the problem of traffic safety on Gali Tel Mill, Ram Nagar, Pahar Ganj Qutab Road, Delhi area due to the movement of Heavy and Light Goods vehicles has assumed serious proportions and is endangering the life of residents and other road users.


Now, therefore, I, Sanjay Singh, Dy. Commissioner of Police, Traffic, Delhi in exercise of the power conferred upon me under regulation 30(1) of the Delhi Control of vehicular and other traffic on road and street regulations 1980 do hereby prohibit the plying of HGVs and MMVs excepting Govt. and emergency vehicles for 24 hours and LGVs for peak hours i.e. from 8.00 AM to 11.00 AM and 5.00 PM to 9.00 PM at Gali Tel Mill Ram Nagar, Pahar Ganj Qutab Road, Delhi.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the Notice Boards of the officers of all District DCsP and all Police Stations in Delhi/New Delhi.

The concerned civic agency and road maintaining authorities shall erect corresponding sign boards indicating the restrictions in the area for the information and convenience of all concerned.

This order shall come into force with immediate effect.
