

NOTIFICATION

Whereas it is necessary to ensure smooth flow of traffic and safety of road users on Mandi- Jaunapur Road in the residential areas of Mandi and Jaunapur Villages.

And whereas the problem of congestion/traffic holds up on Mandi-Jaunapur Road in the residential areas of Mandi and Jaunapur Villages due to the movement of Heavy Goods Vehicles/Medium Goods Vehicles and Light Goods Vehicles has assumed serious proportions and is endangering the life of road users.

Now, therefore, I, Sanjay Baniwal, Dy. Commissioner of Police, Traffic, Delhi in exercise of the power conferred upon me under regulation 30(1) of the Delhi control of vehicular and other traffic on road and street regulations 1980 do hereby prohibit the plying of Heavy/Medium/Light Goods Vehicles on Mandi-Jaunapur Road in the residential areas of Mandi and Jaunapur Villages for 24 hrs.

This order shall be published for the information of the general public in the official gazette and by affixing a copy on the Notice Boards of the officers of all Distt. DCeP and all Police Stations in Delhi/New Delhi.

The concerned civic agency and road maintaining authorities shall erect corresponding sign boards indicating the restrictions in the area for the information and convenience of all concerned.

This order shall come into force with immediate effect.
